

ANNUAL REPORT 2018





Reflecting on our fiscal year 2018 gives us many reasons to celebrate. We built upon our infrastructure using innovative technology, employed best clinical practices, and added primary care to our list of services to help people with mental illness, developmental disabilities, and substance use disorders live their best lives. Indeed, as demonstrated in this report, it was a successful year made possible by our team of dedicated professionals.

One area that continues to play a pivotal role in delivery of services across our seven-county continuum is technology. Telehealth is used daily at AltaPointe to

connect thousands of patients to psychiatric services. The advantage for people living in rural areas or other areas where no psychiatrists are based, is that they no longer have to travel hundreds of miles for services – making telehealth a convenient, efficient, and effective diagnostic and treatment tool. Hospitals across our service area are using telehealth from their emergency departments to connect with AltaPointe physicians. The use of video conferencing improves assessment processes, timeliness of treatment, and outcomes for patients and hospitals.

Meanwhile, growth defines the year for BayPointe Hospital. Additional services and programs enhanced our ability to provide care to an ever increasing number of children. BayPointe's West Mobile Academy expanded classes to include high school students through the twelfth grade and added classrooms for children from North Mobile County who need specialized educational and therapeutic services.

This year also brought an expansion to our school-based therapy program. For the first time, students in our Sylacauga region are enjoying the benefits of receiving counseling services in their school setting. Just as we have seen with our school-based therapy program, we continue to see the benefits of a successful merger with the former Cheaha Regional Mental Health Center and our milestone merger with the former Baldwin County Mental Health Center. The number of services provided continues to grow with an additional 170,000 services provided in FY 2018.

Further proof of our success is the addition of a board-certified child and adolescent psychiatrist to our Sylacauga region's medical staff. He is the only psychiatrist in the four-county area which includes Clay, Coosa, Randolph, and Talladega counties. That means many families no longer face long wait times or transportation hurdles as they seek psychiatric outpatient care.

Concurrently, Integrated Healthcare Pharmacy LLC introduced robotic technology to enhance productivity further. The joint venture between AltaPointe Health and Northrock Pharmacy fills over 6,000 prescriptions a month and allows patients a convenient and economical choice for obtaining their medication.

We renewed our focus on providing staff with a competitive benefits package that now includes affordable, accessible and high-quality primary healthcare by board-certified clinicians at Accordia Health & Wellness. Our state-of-the-art employee-centered clinic in Mobile offers primary care at a reduced rate for employees and their families covered by AltaPointe's health insurance plan. It is part of our initiative to promote healthier living for our employees and our patients.

Perhaps the most exciting news of 2018 was the acquisition of our first Federally Qualified Health Center Look-A-Like, Accordia Health. It is located in the heart of Bayou La Batre and provides affordable primary care services to residents of South Mobile County. Accordia Health is improving AltaPointe's transition to fully-integrated primary and behavioral healthcare.

In closing, whether using technology, expanding services or adding primary healthcare, this year will be remembered as one of tremendous growth and improved efficiencies.






Total Operating Revenue FY 2018



Total Operating Expenses FY 2018




Total Budget Growth and Projection FY 2010-2019



Ethnicity of Patients Served FY 2018




Gender of Patients Served FY 2018



Ages of Patients Served FY 2018






Intellectual Disability

Number of Individuals Served FY 2018




Number of Services Provided FY 2018






CarePointe: Access, Crisis and Other Calls


Total Individuals* Served by Program FY 2018

Total Patients Receiving Hospital Services* FY 2018




AltaPointe's hospital services

AltaPointe operates two free-standing psychiatric hospitals:
BayPointe Hospital located in Mobile, offers a 60-bed acute care
unit, a 34-bed residential unit for children, a 75 capacity
day treatment program with educational component and a
120 capacity after-school day treatment program; and EastPointe
Hospital located in Daphne, offers a 66-bed adult inpatient
crisis stabilization unit and a 16-bed adult crisis residential unit.
AltaPointe's ownership of these inpatient facilities, and its ability
to provide inpatient care, make it the most comprehensive
behavioral healthcare system in Alabama.

Total Services Provided FY 2018




Total Inpatient Services Provided FY 2018




Involuntary 53% • Voluntary 47%



Gender of Patients Served Since August 2018




Ethnicity of Patients Served Since August 2018






Gender of Patients Served FY 2018




