Accordia Health provides primary and behavioral health care services to 45,000 people of all ages living in Coosa County and Mobile County in Southwest Alabama.

Accordia Health is recognized by the Federal Health Resources and Services Administration as a Federally Qualified Health Center (FQHC), meaning that it is a safety-net provider of health care regardless of patients' ability to pay. Discounts are offered on services based on a sliding fee scale depending on household size and income.

Medical services offered at the clinic include treatment for allergic reactions, flu, fever, and sinus infections; management of chronic diseases such as diabetes, high blood pressure, asthma, obesity, and asthma; family planning; annual check-ups; and medical screenings and lab testing.

As a Federally Qualified Health Center, the Accordia Health clinic receives HHS funding and has Federal Public Health Service deemed status with respect to certain health or health-related claims, including medical malpractice claims, for itself and its covered individuals.
